	Over the last few years, most Indiana communities with Combined Sewer Overflows have entered into Agreed Orders with the State or Consent Decrees with the US Environmental Protection Agency. The U.S. EPA has recently issued two guidance documents, one regarding financial capability and affordability burden and one regarding "integrated planning" to increase flexibility to blend water quality programs. This panel will discuss these guidance documents, what options there are to consider with reopening a community's CSO plan, and what some Indiana cities are already doing to reprioritize infrastructure investments based on local priorities.
